

亞太兒童健康研討會

為提昇社會大眾對於兒童環境健康議題的重視，環保署預定於 11 月 8 日~9 日在臺北張榮發基金會國際會議中心舉辦「亞太兒童健康研討會」，邀請國內外重要專家學者，分享兒童環境健康議題，探討未來政府政策措施，使我們的下一代能在更優質的環境中成長。

本次研討會是我國環保署與美國環保署共同推動「國際環境夥伴計畫」活動之一，該計畫從 103 年啟動至今已步入第 4 年，目前已執行 60 餘項環境保護相關議題活動，並有超過 40 個國家代表參與。

兒童因為身體系統仍在發展中，他們的行為易受到更多化學物質和有機物質暴露影響，相較於成年人更容易遭受環境污染傷害。本次研討會特別邀請國內外包括美國、日本、南韓及新加坡等兒童健康專家，分享環境對兒童健康影響研究，並交流如何採取措施保障兒童健康的經驗。研討會結論希望引導產出如何為兒童健康訂定環境管理措施，以因應環境污染等挑戰，未來並透過跨部會合作機制、探討採行措施或制定政策，及可能的國際合作計畫，減少環境污染對兒童健康影響。

該研討會將於 11 月 8 日~9 日在臺北張榮發基金會國際會議中心舉辦。8 日上午將與「2017 環保科技展暨環工學會年會」活動舉行聯合開幕，8 日下午及 9 日全天正式進入兒童健康議題研討，竭誠歡迎有興趣的各界踴躍報名參加，相關資訊詳見 <http://events.ier.org.tw/iepc/apchs/#>。
